

The Illuminati infiltrates the United States

Prior to the Civil War, the Illuminati met in London to decide how to take control of the United States. They needed an event that would weaken the nation in order to make it less defensible against European intrigues.

The event's goals had to accomplish the following: the creation of an expanded central government (more monarchical than democratic); diminished state sovereignty; the reinstatement of a central bank, which would allow monetary control of the United States.

The event that fit the bill would be a civil war.

This war, like all wars that have followed, would have two causes: 1) the one that gets a people fired up and hateful enough to fight; 2) the real cause.

The issue that was used as the emotional cause was slavery. While slavery is a repugnant institution, it was not the reason the war was fought.

The real cause was stated before. It was threefold. The overreaching goal was to siphon off America's resources, money and blood for the Illuminati's purposes.

In preparation for the civil war, the Illuminati—led by the Rothschild banking houses—infiltrated the U.S. to stir up hatred between the North and South over the slavery issue and the disparate notions of government the two held (the North being big business, big government; the South more agrarian and states-rights oriented) and to begin militia-like groups throughout the South that could easily be assimilated into a Confederate fighting force.

The Illuminati, out of England, birthed the Knights of the Golden Circle, among whose members numbered Jefferson Davis, John Wilkes Booth and Jesse James.

Later the Knights would morph into the Ku Klux Klan, led by former Confederate Albert Pike, a 33-degree Scottish Rite Freemason and author of *Morals and Dogma*. Pike is the only Confederate whose statue stands in the District of Columbia.

And for those who think the Confederates were not without their traitors, don't for once think Davis wasn't controlled by his European handlers. And Davis's Secretary of War and later Secretary of State, Judah P. Benjamin, was no better. Benjamin fled to England after his perfidy cost countless Confederate soldiers' their lives and ultimately sabotaged their cause.

David Allen Rivera picks up the story in his *Final Warning: A History of the New World Order*:

“Towards the end of 1861, England sent 8,000 troops to Canada, and in 1862, English, French and Spanish troops landed at Vera Cruz, Mexico, supposedly to collect on debts owed them by Mexico.”

It is reputed that the French troops under Maximilian were sent at the behest of another European power located in Italy.

Aware of how vulnerable America was, Lincoln accepted the aid extended by Czar Alexander II of Russia, whose military had faced the forces of England, France, and the Ottomans in the Crimean War (1854-56).

Rivera states that “as a gesture of goodwill, Lincoln issued his Emancipation Proclamation to free the slaves, just as the Czar had done with the serfs in 1861. On September 8, 1863, at the request of President Lincoln and Secretary of State William H. Seward, Alexander sent the Russian fleet to San Francisco and New York, and ordered them ‘to be ready to fight any power and to take their orders only from Abraham Lincoln.’”

As a further quid-pro-quo, Seward arranged for the purchase of Alaska from Russia. Obviously, America was never invaded either through Canada or Mexico (that is, not until lately). But the nation had been made susceptible to the Illuminati's power.

Lincoln, like John Fitzgerald Kennedy, had made many enemies, and with the former's issuing of "greenbacks"—bonds of sorts that would for the Civil War and would be redeemable for silver—the Illuminati banksters understood that this would cut them out of the process of financing the U.S. at a profit.

Since it is a reality that whatever and/or whoever controls the creation of a nation's money, in turn, controls that nation, the Illuminati had to eliminate Lincoln and, too, the notion of controlling the nation's money supply.

Rivera writes: "Before the Lincoln administration, private commercial banks were able to issue paper money called state bank notes, but that ended with the National Banking Act of 1863, which prohibited the states from creating money. A forerunner of the Federal Reserve Act, it began the movement to abolish redeemable currency. A system of private banks was to receive charters from the federal government which would give them the authorization to issue National Bank Notes. This gave banks the power to control the finances and credit of the country, and provided centralized banking, under Federal control, in times of war.

"Salmon P. Chase, Secretary of the Treasury (1861-64) under Lincoln, publicly said that his role 'in promoting the passage of the National Banking Act was the greatest financial mistake of my life. It has built up a monopoly which affects every interest in the country. It should be repealed, but before that can be accomplished, the people will be arrayed on one side and the bankers on the other, in a contest such as we have never seen before in this country.'"

In 1913, the Federal Reserve Act was passed.

As is stated on *Wikipedia the free encyclopedia*: "Only the U.S. Congress has the power and responsibility to coin money and set its value. In the 1913 Federal Reserve Act however, Congress delegated this power to the Federal Reserve. The constitutionality of this type of action has been controversial."

The Federal Reserve System is not federal, but it definitely is a chain of private banks that now set the value of our money.

In 1913, the sixteenth amendment was also passed, which cleared the way for a graduated income tax, which, by the way, is the second plank of the *Manifesto of the Communist Party* and reads: "A heavy progressive or graduated income tax."
